The goal of the Coalition's Screening Collaborative is to develop and implement a system, that includes policies, procedures and protocols that ensure all children ages birth to 5 are screened for developmental delays and receive the necessary services and supports that promote positive growth and development.

Objective # 1: Coordinate a region-wide screening effort which increases the rates of developmental screening of all children and a central repository/database for tracking of screening history and results

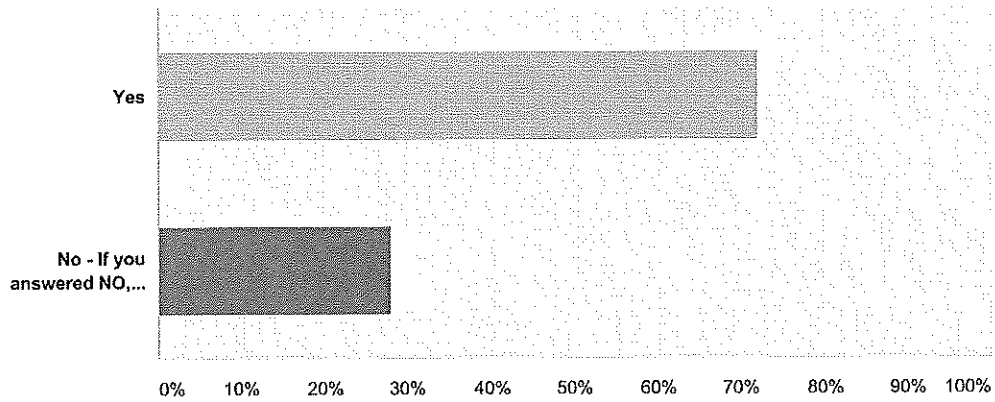

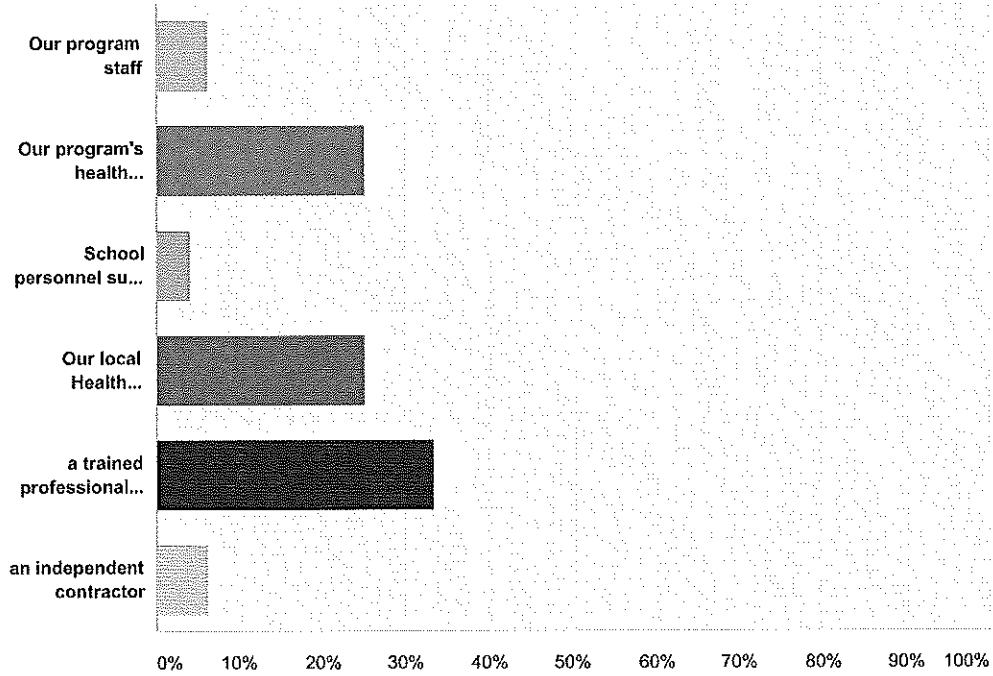

Q14 If yes, who administers the VISION SCREENING?

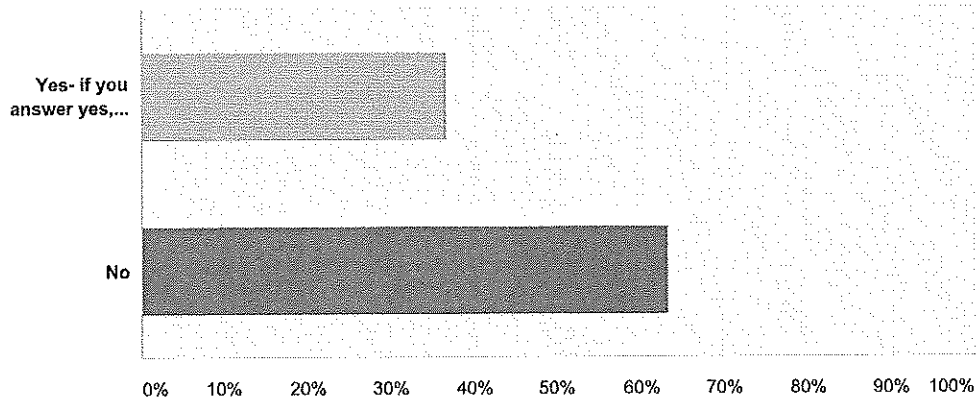

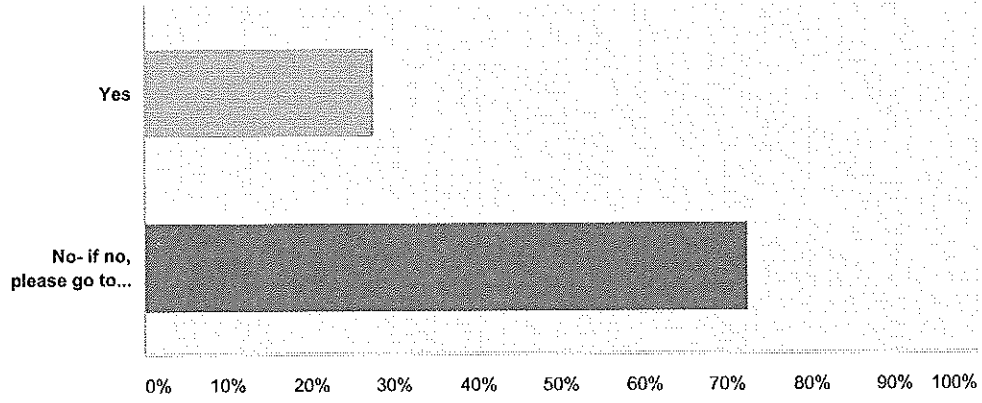

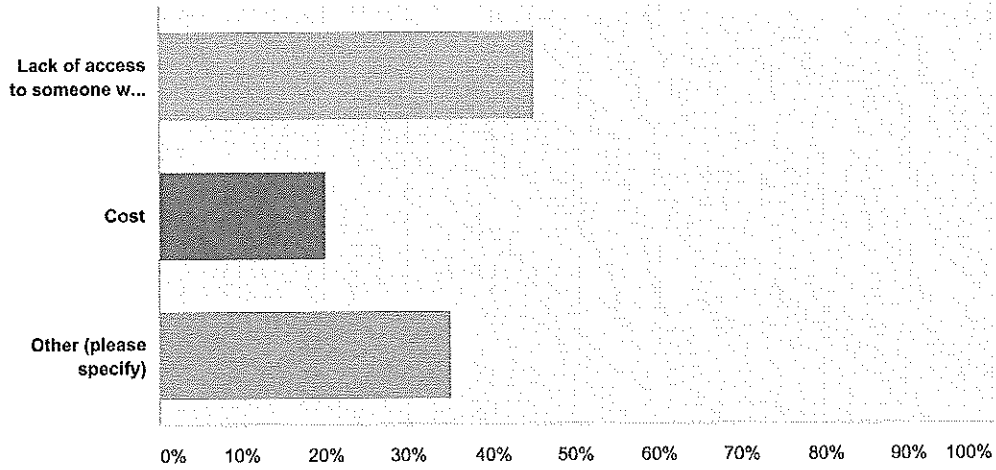

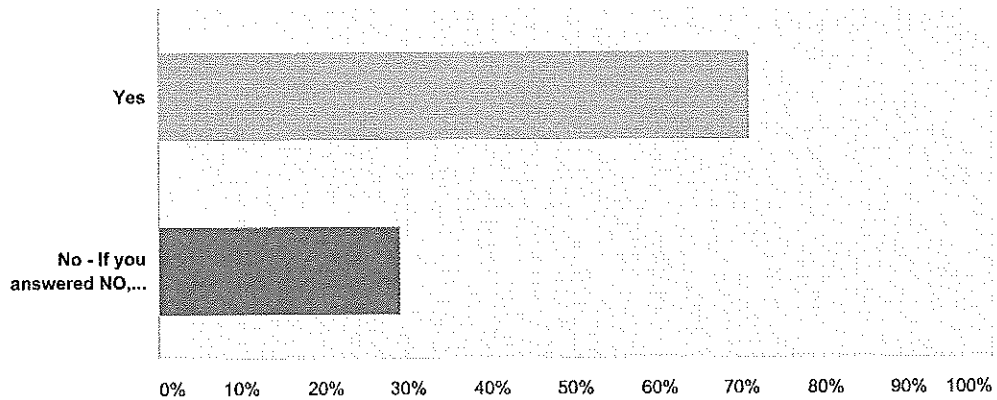

Q21 Does your program currently administer/ coordinate HEARING SCREENING for children in your program?

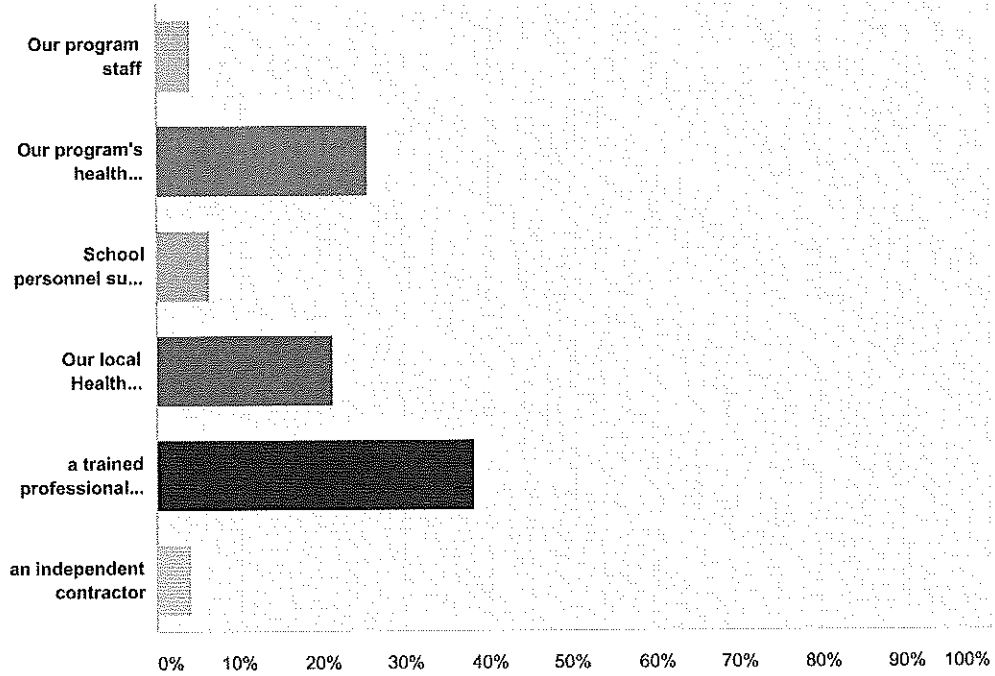

Q22 If yes, who administers the HEARING SCREENING?

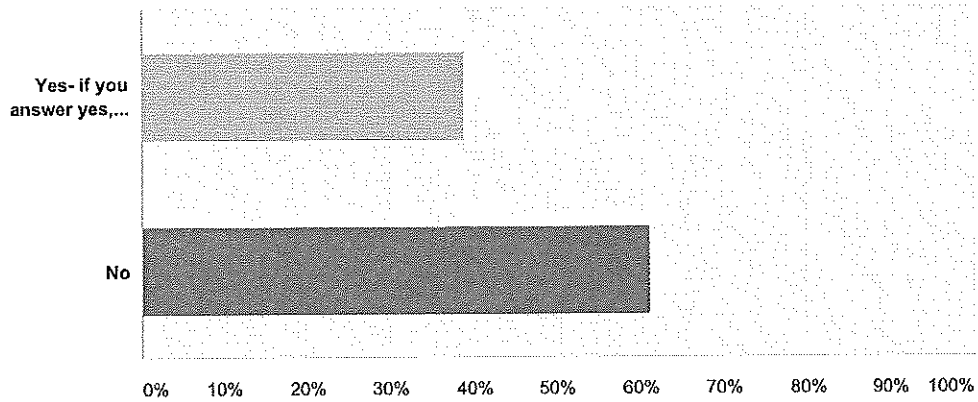

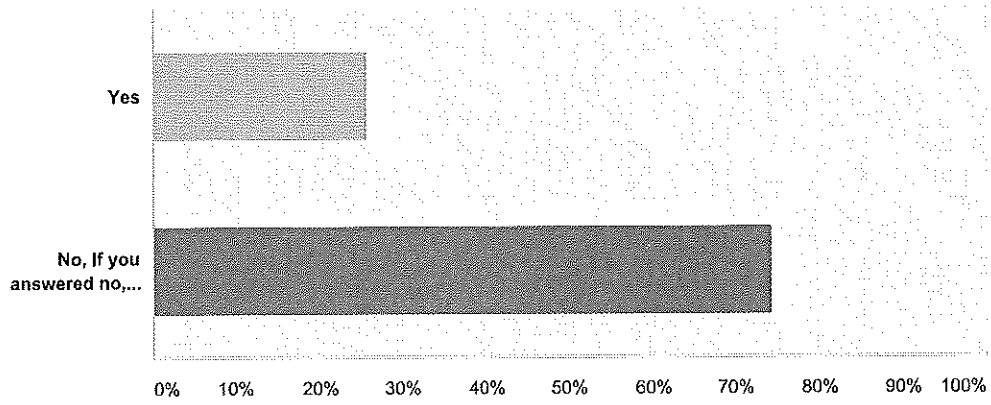

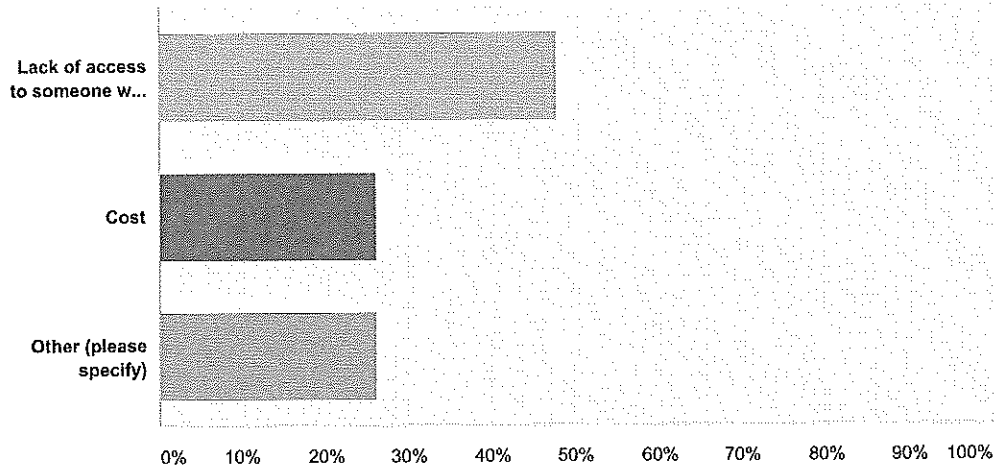
